COPYRIGHT ASSIGNMENT AGREEMENT made by and between _____

and the Miss Minnesota Scholarship Organization.

WHEREAS, Photographer has been commissioned by _____ [Print name of contestant]

to take photographs of her in connection with her participation as a contestant in The Miss Minnesota Scholarship Competition; and

WHEREAS, pursuant to an agreement between the contestant and Miss Minnesota Scholarship Organization, Competition contestants have waived all rights in and to the use of their names and likenesses in connection with the Competition and any commercial activity emanating therefrom.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, the parties agree as follows:

1. **Photographer hereby assigns to Miss Minnesota Scholarship Organization all right, title and interest worldwide in and to the photographs of the Competition contestant, including the copyright as a co-owner with the Photographer. Photographer expressly acknowledges that upon creation of the photographs, Miss Minnesota Scholarship Organization shall have all rights of ownership in and to the photographs, including but not limited to the right to reproduce, display, and distribute them in any medium at Miss Minnesota's sole discretion, and to incorporate them into any other work or to make derivative works from them. Photographer acknowledges that the photographs may be incorporated into commercial works or merchandise, publicity materials, posters, brochures, or other materials or uses which Miss Minnesota Scholarship Organization in its sole discretion shall deem appropriate. Photographer agrees that Miss Minnesota Scholarship Organization does not require the consent of the Photographer to make any such use.**

2. Photographer shall not assert any claim of moral rights (droit moral) in connection with the photographs. Notwithstanding the forgoing, Miss Minnesota Scholarship Organization shall, if possible, provide bylines or give credit to the Photographer when use of the photographs is made. However, the failure of Miss Minnesota Scholarship Organization to credit Photographer shall not be a violation of this Agreement.

3. This Agreement shall be binding, valid and enforceable against, and the benefits thereof shall inure to the parties' successors, licensees, assigns, and parties in privity with them.
