The Miss Minnesota Northern Lights Princess Program is designed to introduce young ladies, ages 5 through 12 years of age, to the Miss Minnesota and Miss America program before they reach competition age and to help them understand that Miss America is not just a dream but something they can begin preparing for at a young age. Local Pageant Directors will be contacted to confirm sponsorship. Parents are responsible for registration fee UNLESS Local Pageant has made other arrangements.

If a Princess is sponsored by a Local Miss titleholder, that Princess can participate in activities and appearances throughout the year that this particular Local titleholder participates in. Northern Lights Princesses can attend other events as a Northern Lights Princess; however, the appearance and recognition will be given to the sponsored Northern Lights Princess at their individual events. This is the same for all Miss and Teen Contestants.

Only the "official" Northern Lights Princess Crown shall be worn for appearances with their sponsored Local Pageant. Once they receive the state Northern Lights Princess crown, they may wear these during the remainder of their term of participation. The National Crown (Pink Stones) is not to be worn.

The dates for these rules and requirements are: June 17, 2016 – March 15, 2017. Northern Lights Princesses must re-register to participate as a Northern Lights Princess following the last Miss Minnesota local pageant to compete at 2017 Miss Minnesota Pageant. Last local pageant is first weekend in March, 2017, but will be announced.

NORTHERN LIGHTS PRINCESS PROGRAM GUIDELINES

- **Who can be a Princess?**

Any young lady who is at least 5 years of age and no older than 12 by the date of June 1, 2016 is eligible to enter.

- **Applications**

It is the responsibility of the princess parents/guardians to make sure that applications and other paperwork is completed appropriately and in a timely manner. The \$250.00 registration fee may be paid by the supporting local pageant, the Princess's family or the applicant can get sponsorships from businesses, family or friends.

- **Official Princess Crowns**

The Official Crown will be provided to each Princess upon arrival for Miss Minnesota week. The crown is not a toy and should be handled with care. It should not be worn except on official appearances as a Minnesota Northern Lights Princess. If the crown is broken, replacement crowns can be purchased for \$75.

- **Dress and Activities**

Each princess is required to have a solid white party dress which is either knee length or T-length. NO floor length dresses will be allowed. This dress & official crown will be worn on stage final night of Miss Minnesota during opening production and evening gown competition.

1. Each Northern Lights Princess must submit a one (1) color or black/white headshot in 5x7 sizes. Photo should be head and shoulders only and **MUST** be sent with application.
2. Place a label on the back of the picture which contains the name of the Northern Lights Princess and the Miss Contestant name and title for which she is a Princess. If she doesn't know a Miss Contestant, we will assign her one!
